Each board member is appointed by an Order-in-Council – the Ministry of Health and Long-Term Care's selection and appointment process – and is appointed for a term of one to three years, subject to two terms up to a six-year maximum.
- The Chair and the Directors are appointed based on their expertise, experience, leadership skills and the needs of the LHIN and are accountable, through the Chair, to the Minister of Health and Long-Term Care for the LHIN's use of public funds and for its results in the local health system.
